- 10.0 Bids shall be evaluated on the basis of total bid price (Including GST) for the entire scope of work under the work.

- (b) Balance ten percent (10%) would be paid after successful erection, testing and commissioning of entire work and issuance of Taking Over Certificate.

Erection Price Component :

- (a) 90 of Erection Charges shall be paid on pro-rata basis after installation at site and on certification by the I/c Engg (Timul)
(b) The balance 10% (Ten percent) of the erection price component shall be paid on completion of entire work, successful testing & commissioning and issuance of Taking Over Certificate.

- 15.0 **Taxes and Duties** : The quoted prices must be inclusive of all taxes, duties & levies including Works Contract Tax, service Tax etc. Income tax, if applicable, shall be deducted at source without any reimbursement for which TDS certificate shall be issued. As price are inclusive of Service Tax. T.D.U.S.S. Ltd shall deduct the Service Tax portion applicable to service receiver from the payable amount of bill and deposit with the Service Tax Authorities under reverse charge mechanism as per latest financial Act.
