Qualifying Criteria:-

- 1) The bidder should be registered under company act 1956. Partnership firm, Proprietorship firm, Pvt. Ltd. Firm, NSIC, MSME with all statutory provision like GST, PAN, etc. as the case may be Documentary proof to be furnished. Manufacturer of same product will be given preference.
- 2) The bidder should have experience of at least One year in same name and style. Copies of orders in support of the statement should be uploaded and at least one performance certificate.
- 3) The bidder should not be black listed by Central/State Govt. or its Agency/ utility/ enterprises. An affidavit in this effect may be uploaded.
- 4) The bidder must be financially sound and will submit proof for the same in form of annual turnover of 35.00 Lacs or Bank solvency certificate of minimum 50.00 Lacs. Copies of Balance Sheet, P&L of last year must be uploaded. In case of MSME relaxation in Turnover may be given.
- 5) Validity of bid shall be 90 days from the date of opening of tender.
